1. 4. I have encouraged participation in the Astronomy League's "clubs" whereby members can undertake an activity, learn more about astronomy and get a certificate of recognition for it. 5. We have encouraged outreach activities and I am proud to say that Trevor led the way to establishing a monthly telescope viewing sessions for the public at a Starbucks Coffee and a Best Buy store. However, We need to have more members involved in the outreach activity.

6. Although we lost Craig Brenden as the newsletter editor, we have a good replacement in the way of Geoff Michelli. As you can see from the last few newsletters, Geoff is off and running.


